This program provides financial support for low-income and moderate-income families to cover some of the extra costs of caring for a child who has a severe disability.

Families who are caring for a child with a developmental and/or physical disability can apply to the Special Services at Home (SSAH) program to get funding for:

- -primary caregiver relief and related supports
- -activities of personal growth or development for the child, including camps and recreational activities, like swimming and music classes.

Enhanced Autism Respite

Modest funding dispersed quarterly to families of Children/youth diagnosed with ASD for respite and fees for attending recreational/social programs e.g. camps, swim lessons, cadets etc.

In Home Respite

For Families residing in Dryden or surrounding area with child/youth diagnosed with a developmental disability and/or serious on-going medical condition. https://www.fireflynw.ca/for-families/

Out of Home Respite

For highest needs families with potential risk of breakdown unless regular respite is provided. Must reside in the Kenora/Rainy River Districts, be under 18 years of age, living at home with parent/caregiver and have more than one disability related need for which support is required to participate in activities of daily living, school and play.

*Should_first apply to funding programs eligible for; SSAH, ACSD, Jordan's Principle and KRRCFS Family Respite Program.

Ontario Works Discretionary Benefits under Special Services, Items and Payments (for OW and ODSP recipients)

If parents/caregivers are ODSP or OW recipients, there may be funding that can be provided to cover one-time exceptional costs for health and non-health related expenses. Discretionary benefits are provided on a case-by-case basis, as assessed by the Administrator. Contact your OW/ODSP worker directly to initiate the application process.

KidSport

-supports children who need financial assistance with sport registration fees and equipment costs. KidSport Ontario provides grants of up to \$250 per eligible kid, per year (January 1st - December 31st) towards sport registration fees.

Disability Tax Credit (DTC)

The Disability Tax Credit is a non-refundable tax credit that helps people with impairments, or their supporting family member/caregiver to reduce the amount of income tax they may have to pay.

Transition to Adult Services:

Developmental Services Ontario (DSO)

Developmental Services Ontario manages the application process for all provincially-funded developmental services and supports for adults with a developmental disability in Ontario.

Applications to DSO can begin when a youth is 16 years old.

Passport Program

Passport is a funding program that helps adults 18 years or older with a developmental disability to participate in their communities and live as independently as possible. It also helps caregivers of an adult with a developmental disability take a break from their caregiving responsibilities. Applications for Passport Program is managed through Developmental Services Ontario (DSO)

The Ontario Disability Support Program provides income support, benefits for health costs and other disability supports to people over the age of 18 who are financially eligible and meet medical/disability criteria.
